- 1 load compactible sand \$320.00

PLACE AND FINISH:

- Set up, pour and finish approx. 452.16 sq.ft. (24' diameter) of 4" thick #4 1/2" rebar reinforcement Grain bin @ \$16.00/sq.ft. \$7,234.60
 - 75.36 ln.ft. of concrete footing @ \$9.00/ln.ft. \$678.25
- TOTAL \$9,432.85

- Concrete footings will have 2 perimeter strands #4 1/2" rebar reinforcement
- Concrete will have 6" grade elevation
- Concrete will be of broom finish with saw cut control joints
- Concrete will be of 4000 PSI
